



Additive labeling	<p><i>Pictorial Representations on Food Labels</i></p> <p><b>Section 34</b></p> <p>(1) Where a <b>flavouring ingredient is added</b> to a prepackaged product that is a food and the ingredient is not derived from such natural substances as meat, fish, poultry, fruits, vegetables, edible yeast, herbs, spices, bark, buds, roots, leaves or other plant material and the label of the prepackaged product shows a pictorial representation that connotes the natural food flavour that is being simulated by the added flavouring ingredient, the label shall contain information that the <b>added flavouring ingredient</b> is imitation, artificial or simulated.</p> <p>(2) The information referred to in subsection (1) shall be easily legible and in letters at least the same size as the sizes prescribed in subsection 14(2).</p> <p>(3) Where a pictorial representation referred to in subsection (1) appears</p> <ul style="list-style-type: none"><li>(a) on the <a href="#">principal display panel</a>, the information referred to in that subsection shall be shown on or adjacent to the pictorial representation;</li><li>(b) on a part of the label other than the principal display panel, the information shall be shown on the principal display panel, adjacent to the common name of the prepackaged product; or</li><li>(c) on the principal display panel and on any other part of the label, the information shall be shown on or adjacent to the pictorial representation on the principal display panel."</li></ul>

## 1. Regulations provided by the legislation of the domestic economy.

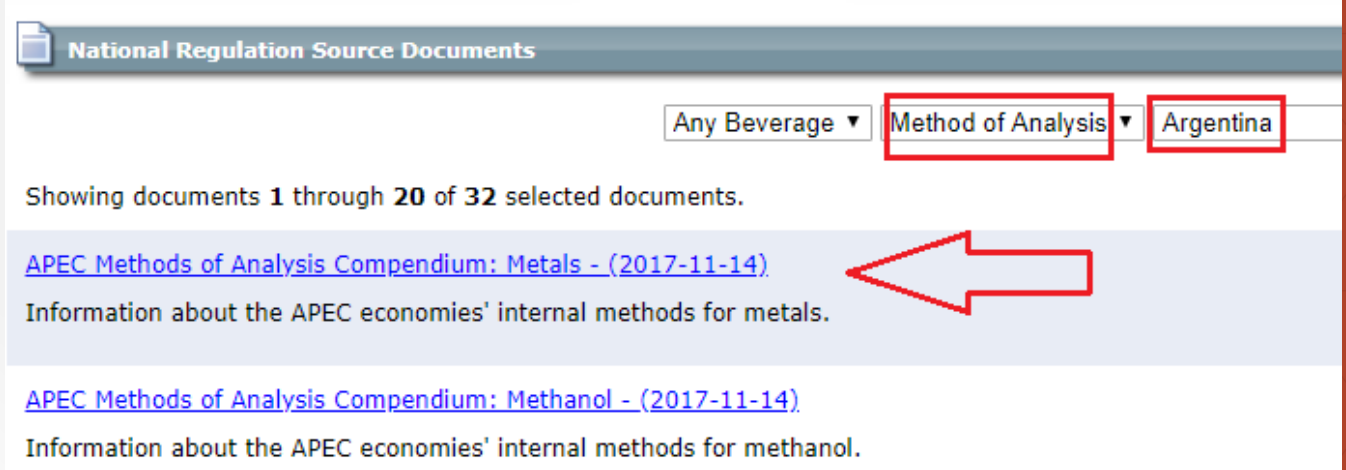


